

# Dos & Don'ts

What you may and may not say (or write)!



## Basic issues:

- 1) Only the TimeWaver Frequency system is a medical device in Europe and also in some other countries such as the USA, Taiwan, Australia and Singapore. In these countries, this product may also be promoted for the treatment of certain indications. These areas are listed below.
- 2) TimeWaver products must not be promoted beyond the limits stated in the notices and disclaimers. Particularly critical are health-related statements such as "medicine of the future".
- 3) The notices and disclaimers provided by TimeWaver should be clearly visible in all public presentations (print, video, web). In case of changes, we will notify you as soon as possible. The notices and disclaimers are listed at the very bottom of the PDF for copying. You can also find them on the website.
- 4) No medical statements may be made about the wellness applications of TimeWaver products:
  - Instead of "treating health problems", "treating diseases" etc. > "harmonizing dysbalances"
  - Instead of "therapy" or "treatment" > "application"

- 6) Instead of "Information Field Medicine", etc. > Information Field technology
- 7) Please do not publish price lists or any of our PDFs on the internet, in particular the old brochures in PDF format. If you need TimeWaver promotional materials, please contact us directly. We will provide you with media that is suitable for publication.
